

Hazrat Data Ganj Bakhsh Ali Hajveri: The illuminated path of Sufi spirituality

Sufism in the context of Pakistan and Islam Sufism has played a major role in shaping the spiritual and cultural history of Pakistan. In a country that is often characterised by rigid interpretations of Islam, Sufism paved the way for a counterbalance, through emphasis on spirituality, mysticism, and the pursuit of a direct connection with the divine. Moreover, Sufi philosophy and practices have contributed to the promotion of tolerance, interfaith harmony, and a deep reverence for humanity. Aside from the preachings, there have been significant contributions from the perspective of poetry and music. These creative contributions, which were revolutionary for their time, revolve around peace, humanity, and tolerance. This has resulted in the Sufi perspective being adopted for religions other than Islam.

In the broader context of Islam, Sufism has wielded a profound influence on the interpretation and practice of the faith. Sufi saints have helped further the image of Prophet Muhammad, thus forming a large Muslim society. Islamic tradition has been considerably influenced by the emphasis that Sufi saints place on love and spirituality. Additionally, Sufi scholars and mystics have contributed significantly to Islamic jurisprudence, theology, and philosophy, offering alternative perspectives on the faith. These themes have helped facilitate dialogues with other religious and philosophical systems.

In the context of Sufi mysticism, Hazrat Data Ganj Bakhsh Ali Hajveri is one of the most revered and influential Sufi saints in Pakistan's history. His life and teachings have revolved around themes of love, spiritual enlightenment, and profound wisdom. He believed that: "The world is a shadow, and God is the substance. The wise person does not chase shadows; he pursues the substance."

The origins and spiritual awakening of Ali Hajveri

Ali Hajveri was born in Ghazni (in present-day Afghanistan), an ancient city with a rich history of scholarship and spirituality, in the year 990 CE. He was born into a family that was devoutly pious and religious, characterising his childhood with a rich scholarly and theological heritage. This helped him to further his natural intellectual and religious curiosity. As he delved into the Quran, Hadith, law, and theology, Ali Hajveri demonstrated an exceptional aptitude for understanding and interpreting Islamic teachings.

Claiming that "the spiritual path is a journey from the self to the Self," he embarked on a momentously spiritual journey in 1031 AD, through Persia, Syria, and Iraq. He took from each place a different understanding of Sufism, shaped through the lens of the country's individual cultures and spiritual practices.

He eventually reached Lahore, a hub of learning and culture, where amidst a vibrant intellectual milieu, Ali Hajveri found fertile ground to sow the seeds of Sufism. It was over here that he established himself as a teacher and preacher, speaking on love for God, spiritual guidance, purification of the soul, and compassion towards others.

Teachings of love, tolerance, and spiritual awakening

At its essence, Hajveri's doctrine revolves around the transformative efficacy of love and devotion. He firmly postulated that love for the Divine represents the ultimate wellspring of salvation and the anchor for spiritual enlightenment. His discernment of the complexities and nuances of Sufism took shape in literary form.

The central ideals of Hajveri's teachings reside in his magnum opus, "Kashf al-Mahjub," which can be translated as "The Revelation of the Veiled." This revered treatise encapsulates the doctrines of Sufism and is used contemporarily by those who wish to take on the course of understanding Sufi spirituality, self-discovery, and the quest for divine communion. The book, which illuminates the trajectory of Sufi spirituality, resulted in Hajveri being regarded as a preeminent authority of Sufism. His other notable seminal works include "Minhaj al-Din" (The Path of Religion) and "Adab al-Muridin" (The Etiquette of Disciples).

However, Hajveri's teachings are not limited to this, as he also highlighted how it was important to showcase a profound love for all of God's creations. His core values include compassion, inclusivity, and interconnectedness. A major pillar of his teachings is the ethos of tolerance. Hajveri held that a true seeker of the Divine must display tolerance when faced with a multitude of perspectives and religious beliefs. This meant that tolerance goes beyond the domain of religious implications.

Besides this, Hajveri underlined the magnitude of spiritual awakening and self-purification. According to him, the journey toward God required upholding sincerity and unwavering devotion to the Divine. From his perspective, one had to be deeply introspective and display purity and authenticity during this journey.

Followers of Ali Hajveri

The followers of Hajveri, affectionately known as Data Ganj Bakhshis, are heterogeneous, as they belong to a wide spectrum of ethnic, cultural, and social backgrounds. Data Ganj Bakhshis shape their lives around Hajveri's emphasis on love as the path to God, thereby leading lives characterised by compassion and service to others.

However, the impact of Hajveri's teachings has spread beyond his shrine, with his followers engaging in acts of charity and community service, reflecting the Sufi emphasis on social responsibility. The main mission of his followers is to instil a positive change within society by upholding values of generosity and kindness.

These values have also had implications outside Pakistan. By preaching love, tolerance, and spiritual awakening, Hajveri has attracted diverse followers from outside Pakistan. For instance, he is deeply revered by Muslims in India (particularly in Punjab, Haryana, and Uttar Pradesh), Bangladesh, and Afghanistan, who make annual pilgrimages to his tomb shrine in Lahore, seeking blessings and guidance. Sufism in Iran and Turkey has been impacted by Hajveri's teachings, with many scholars studying his works.

Additionally, his works have gained increasing popularity and North America and Europe. The growing interest in Sufism in these areas has led to many of his texts being translated into English, making them accessible to a wider audience.

Enduring contributions to Sufism and Islamic mysticism

In a world that is becoming increasingly polarised, Hajveri's teachings and core values are being more regarded than ever. The ideals of universal love, tolerance, and spiritual awakening, being inherently transcultural and unconstrained by geographic confines, have attracted individuals from all walks of life. His teachings on ethical conduct and social responsibility are also highly relevant in today's world, with his followers looking at these values as a message of unity and understanding.

The Data Darbar in Lahore remains a symbol of spiritual awakening and inclusivity, welcoming individuals of all backgrounds and beliefs. It serves as a testament to the enduring influence of Hajveri, offering solace and inspiration to all who seek it.

Multiple organisations are working in contemporary times based on the preachings of Hajveri. The Data Ganj Bakhsh Trust is working presently in Pakistan towards promoting peace and interfaith dialogue through education and social development programs. In India, the Data Ganj Bakhsh Foundation aims to spread Sufism and its message of love and compassion. Additionally, in the United States, the Data Ganj Bakhsh Circle fosters spiritual growth and community among Muslims and non-Muslims.

5 September 2023 marked the 980th annual Ur celebrations of Data Ganj Bakhsh at Lahore, where "fateha" was offered by visitors, along with special prayers for the solidarity of Pakistan. The event, which was inaugurated by the caretaker chief minister of Punjab and the former finance minister, will last for three days and will host devotees from all over the world. The Punjab Auqaf and Religious Affairs Department has allocated PKR 125 million for langer (free food) to devotees.

CPEC Post-BRI Forum 2023: Agreements, security, and implications *By Dhriti Mukherjee*

On 20 October, Prime Minister Anwaarul Haq Kakar returned from Beijing, after attending the five-day Belt and Road Initiative (BRI) Forum. During this meeting, Pakistan and China strengthened their longstanding partnership, thus signifying a renewed commitment to the China-Pakistan Economic Corridor (CPEC). It also resulted in various agreements and Memoranda of Understanding (MoUs) being signed. Pakistan thereby gained a lot from the forum, securing its position as the 'key link' in Beijing's BRI. On the other hand, China asserted itself as a pioneer of "economic multilateralism and globalisation."

Agreements and MoUs

During Kakar's visit, he stated that "Pakistan views its ties with China as a longstanding strategic partnership," and on these lines, 20 agreements covering diverse sectors were signed. They centred around currency swapping, peace talks, infrastructure development, and even a lunar research station. Chinese President Xi Jinping believes that getting involved in different sectors would support an "upgraded version" of CPEC. A statement released after the visit underscored the commitment of both nations to support each other on issues vital to their core interests. Pakistan reaffirmed its adherence to the one-China principle and opposition to "Taiwan independence," signifying its strong alignment with China on sensitive geopolitical matters.

Furthermore, both countries witnessed the signing of an initial cooperation agreement on the lunar research station project. According to the China National Space Administration, the collaboration encompasses engineering and operational aspects of the Chinese lunar base program. This endeavour, combined with China's goal to send astronauts to the moon, underlines China's ambition to become a significant space power by 2030.

Security concerns

While China remains a vital ally and investor in Pakistan, Jinping and the Chinese foreign ministry voiced security concerns that they had. Pakistan has witnessed attacks on Chinese personnel and projects. Jinping emphasised the need for security guarantees, stating, "We hope the Pakistani side will guarantee the safety of Chinese institutions and personnel in Pakistan."

The future of CPEC

CPEC, often regarded as the flagship project of the BRI, is crucial for both nations. As Pakistan completes numerous projects under CPEC, there is a renewed focus on expanding the scope of this economic corridor. Both countries aim to enhance cooperation in various domains, including industrial parks, agriculture, mining, and new energy. Early implementation of major connectivity projects is also on the agenda. However, the issue of revenue distribution within CPEC has garnered attention.

Harsh V Pant's article, "Responding to the China-Pakistan Economic Corridor Challenge," suggested that China acquires 91 per cent of the revenue generated by CPEC, leaving Pakistan with a meagre nine per cent. Although specific data to substantiate this claim is not readily available, there are "growing voices in Pakistan that China seems to be a bigger beneficiary from CPEC than Pakistan." The Chinese view, on the other hand, as expressed by the Chinese ambassador to Pakistan Sun Weidong, is that the trade balance will only be rectified when Chinese companies produce those goods in Pakistan that have a Chinese demand.

An additional angle explored by Pant was the evidence that the "viability of CPEC requires India's participation." However, continued Indian opposition to this proposition "galvanized those who remain suspicious of Chinese motives behind Obor in Pakistan as well as in the rest of the world."

All set for Nawaz Sharif's homecoming By Shamini Velayutham

On 19 October, Former Prime Minister Nawaz Sharif was granted protective bail by the Islamabad High Court in the Avenfield and Al-Azizia cases until 24 October after the National Accountability Bureau (NAB) did not object to the petitions that were filed by the Pakistan Muslim League-Nawaz (PML-N) supreme leader before his scheduled return from self-imposed exile on 21 October. As part of its investigation into the Toshakhana case, an accountability court in Islamabad revoked the perpetual arrest warrants issued against the former prime minister in the graft cases involving a vehicle.

On 18 October, the petitions from the Nawaz were heard by a two-person Islamabad High Court (IHC) bench made up of Chief Justice Aamer Farooq and Justice Miangul Hassan Aurangzeb. Special prosecutors Muhammad Rafay Maqsood and Muhammad Afzal Qureshi appeared before the court together with Deputy Prosecutor General Naeem Tariq Sanghera. After that, the IHC made the decision public and prohibited the authorities from detaining Nawaz upon his return.

Where is the PML-N supremo now?

On 18 October, PML-N supremo Nawaz Sharif arrived in the United Arab Emirates (UAE) before his anticipated return to Pakistan. On 21 October, he will return to Pakistan after living in self-exile in London for four years. Despite having been given a prison term, he was permitted to fly. He was held up in Jeddah, Saudi Arabia, for a crucial meeting, according to sources who spoke to Geo News, which caused him to arrive after a little delay. At the airport in Dubai, he was given "special protocol." Nawaz will spend his two days in Dubai with a small group of people before departing for Pakistan, travelling first to Islamabad and then to Lahore.

PML-N's responses

The PML-N is in control of the past, present, and future, according to the party's Senior Vice

President Maryam Nawaz Sharif, who spoke during a ceremony. The new party song, which details the party's historical upheavals, was formally introduced during the occasion by PMLN President Shehbaz Sharif. The people who had aimed to destroy Nawaz, according to Maryam Nawaz, are no longer involved. She thanked the Former Minister of Information Marriyum Aurangzeb, for his assistance in launching the anthem.

Meanwhile, Shehbaz Sharif expressed his heartfelt congratulations on the anthem's debut to Maryam, Marriyum Aurangzeb, and their entire team. He stated that the party's youth wing would give Nawaz Sharif a historic welcome on October 21. "We have to honour Nawaz Sharif by, according to him, the biggest welcome in the country's history. I also thank the party leaders for their efforts to stage a historic welcome for Nawaz Sharif," he insisted. Shehbaz added that Nawaz's homecoming was not an act of retribution but rather an effort to hasten the country's development and help it navigate its current challenges.

PPP and PTI contentions

The PPP and the PTI both argued that the IHC's decision to grant bail to the former prime minister was unlawful, and this did not sit well with the court. The ruling was described as a "murder of justice and law" in a statement made by the PTI spokesperson, who called it the "darkest day" in the nation's legal history. The PTI spokesperson recalled that although the country had waged a long and difficult battle for judicial independence, the court itself had damaged the rule of law and the administration of justice via its own "flawed and compromised" rulings. The spokesperson claimed that a section of the judiciary was acting as "an open facilitator in the ongoing political engineering". Separately, the PPP's leadership in Punjab said that "favours and concessions were being showered on a particular party as the caretaker government and some institutions were openly facilitating" the PML-N. They said that the protected bail granted to Mr Sharif was a first in legal history.

Kakar reaffirms CPEC's future at the BRI forum By Femy Francis

On 18 October, Interim Prime Minister Anwaarul Haq Kakar reaffirmed Pakistan's resolves to further China -Pakistan Economic Corridor (CPEC) while attending the third Belt and Road Initiative Forum (BRI) in Beijing, China. Kakar congratulated Beijing on the 10th anniversary of BRI and expressed the significance of the initiative being paramount for the world to advance connectivity and shared prosperity. He hoped that moving forward, the BRI would look into uplifting rural farmers, education and supporting small businesses. Kakar said: "This vision promotes cooperation, collective security, inclusive and sustainable development, and a balanced ecosystem as the only way to address global challenges."

Chinese Premier Li Qiang expressed his satisfaction and support for the steadily growing CPEC relations and noted the positive momentum the bilateral cooperation was heading towards. Pakistan is looking forward to continuing this engagement and even endorsed Chinese global vision and connectivity, said Kakar. He pointed the CPEC has played a vital role in generating new economic life and opportunity into Pakistan.

Fifty projects accomplished under CPEC, says Kakar

Interim Prime Minister Anwaarul Haq Kakar also announced at the meeting that USD 25 billion worth 50 project have come to fruition and have been completed under CPEC. He said that they successfully completed the construction of an airport at the southwestern Gwadar port. On 18 October, Chinese state media Xinhua reported of the "China-funded airport in Pakistan to facilitate regional connectivity" called Gwadar International Airport in Balochistan. The building of the expensive airport came under scrutiny comparing it to China funded airport in Nepal called Pokhara International airport, that is now saddling the debt owed to China. China has heavily invested in the area that stands crucial to the shipping route to the Arabian Sea through the Strait of Hormuz, while the possibility of it becoming a vibrant route incurring revenue is questioned. Kakar also announced the plans to complete clean energy projects in four to five years. Some of the major CPEC projects in Pakistan include the following:

- Gwadar Smart Port City Master Plan
- Gwadar Eastbay Expressway
- China Hub Coal Power Project, Hub Balochistan
- Sahiwal Coal-fired Power Plant
- Sachal Wind Farm, Jhimpir, Thatta
- Karot Hydropower Project, AJK/Punjab

Mainline-1 railway project signed between Islamabad and Beijing

The highlight of the growing China-Pakistan collaboration at the BRI forum was the signing of the Mainline-1/ML-1 project worth USD 7 billion aiming to connect the Northwest city of Peshawar to the Southern port city of Karachi by establishing a 2,600-kilometer track. Secretary to Pakistan's Ministry of Railway Syed Mazhar Ali Shah stated that the project would transform the Pakistan transportation network and they would increase the railways market share from 2 per cent to 40 per cent while creating employment opportunities for 20,000 jobs.

Kakar on Debt Traps

Kakar dismissed the allegations that participation in BRI has led several countries to "Debt Trap" and stated that the Chinese model of development financing is without any conditionalities and is entirely different from any other traditional financial models of development. He vehemently opposed the claims that BRI financing leads to debt traps on the contrary he stated the vitality of BRI by calling it an "essential tool" to help countries, "in achieving comprehensive and inclusive development of their peoples."

PTI wants the "bat" symbol to be assigned On 20 October, PTI requested ECP to allot the "bat" as its electoral symbol for the upcoming general elections. The party, which has complained about the absence of fair competition, called the delay in the release of the election symbol "unjustifiable" and "intolerable." The excessive delay and non-issuance of the oral decision announced on 30 August raised many eyebrows, hence the ECP should soon issue its full written ruling pertaining to the party election symbol, according to a PTI spokeswoman in a press release. The watchdog had no legitimate reason under the law or the constitution to withhold the party's election symbol, the spokesman encouraged the watchdog to issue a comprehensive decision as soon as possible in accordance with the verbal order issued on 30 August. A farce, according to the spokesman, would be free, fair, and transparent elections "without the largest and most formidable political force of the country." He continued by saying that the "conspiracy to keep PTI out of the electoral arena on the state-mandated and unknown technical grou-nds" amounted to an assault on the nation's political system and constitution. SC to hear petitions opposing civilian military trials

On 20 October, a five-member Supreme Court bench will hear approximately a dozen petitions contesting the prosecutions of civilians in military courts on 23 October (Monday). Following the unrest on 9 May, the National Assembly issued a resolution calling for the rioters to be tried under the Army Act. Days later, the army had disclosed that military proceedings against "102 miscreants" were in progress. The bench is presided over by Justice Ijazul Ahsan and is composed of Justices Munib Akhtar, Yahya Afridi, Mazahar Ali Akbar Naqvi, and Ayesha Malik. The hearing is slated to start on 23 October at 11:30 a.m., according to the cause list released by the Supreme Court. The PTI, former Pakistani leader Imran Khan, the Supreme Court Bar Association (SCBA), PPP politician Aitzaz Ahsan, former Pakistani Chief Justice Jawwad S. Khawaja, five members of the civil society, Junaid Razzaq, and Zaman Khan Vardag are among the parties who have filed arguments. Pakistan Supreme Court may hear cases on trial of civilians by military courts and general elections

On 20 October, Dawn reported that Chief Justice Oazi Faez Isa has hinted that the Supreme Court (SC) may take up important constitutional matters in the coming weeks. These matters include the trial of civilians by military courts and issues related to the holding of general elections. The court has been urged to fix the military court case as early as possible, as concerns have been raised about the trial of civilians commencing in violation of previous SC directions. The court is also considering a petition by PTI, seeking a direction for the announcement of a date for elections within 90 days of the dissolution of the National Assembly. 100 protesting teachers and female healthcare workers arrest in Lahore

On 19 October, during a protest demanding the reinstatement of leave encashment, reversal of revisions to pension regulations, and cancellation of privatization plans for public schools, police arrested over 100 more teachers, lady health workers (LHWs), and other government employees. Aiwan-i-Adl to PMG Chowk was the route of a rally organized by the All-Government Employees Grand Alliance (Agega). A coalition of 34 organizations, including those from the health, education, and higher education ministries of government, continued to demonstrate against the Punjab government and the district administration over the detention of more than 200 teachers who were already in jail. Pakistan Election Commission issues production orders for Imran Khan

On 19 October, the Election Commission of Pakistan issued production orders for Imran Khan to appear in contempt cases scheduled for a hearing on 24 October. The written order stated: "Since the respondent is in jail and his personal appearance is mandatory to proceed further with the matter. In such view of the matter, there is no alternative except to issue production order of respondent namely Imran Ahmed Khan Niazi." The production order directs that he be produced before the Election Commission of Pakistan on the specified date, after which he will be returned to jail. The cases involve charges of contempt of the Commission and the Chief Election Commissioner. Additionally, bailable warrants have been issued for former PTI leader Fawad Chaudhry for his nonappearance. Bilawal Bhutto-Zardari criticises Nawaz Sharif, urges Election Commission to announce polls date

On 18 October, PPP chairman Bilawal Bhutto-Zardari criticised PML-N leader Nawaz Sharif for his return to Pakistan, stating that "the Constitution, election, and democracy were halted due to one person's return." Despite being partners in the previous government and demanding Nawaz Sharif's return, the PPP has raised concerns about special treatment for him. Zardari called for an end to the politics of division and abuse, stating that the delaying of elections, which had been a "bitter pill" for PPP to swallow, is a "disrespect" to the Constitution. He urged political parties to support the PPP's demand for the Election Commission of Pakistan (ECP) to "immediately announce the date for the polls." NAB has no objections as Nawaz requests bail through the IHC

On 18 October, Nawaz Sharif, the party's supreme leader, was granted protective bail in the Avenfield and Al-Azizia cases by the Islamabad High Court (IHC) in advance of his return from London on Saturday. A NAB counsel said that the accountability watchdog had no objections to the pleas made by elder Sharif. Cotton production rises by 22 per cent to approximately 6 million bales

However, Sindh saw an unprecedented 84 per cent gain in cotton production during this time, whereas Punjab saw a 16 percent decline. 5.99 million bales of cotton, or 1.08 million more than the total production of the previous cotton season, had arrived in the nation's ginning plants by 15 October. 3.45 million bales of cotton arrived in Sindh, which is 84 per cent greater than the province's whole lint production for the previous year. According to the Cotton Ginners Forum chairman Ihsanul Haq, heavy whitefly attack on the crop, which caused cotton production to remain significantly below expectations and raise concerns that this year's total domestic production of cotton will be 9 million bales rather than the revised target of 11.5 million bales, was to blame for the decline. According to him, the primary cause of this reality is the persistent decline in the value of the dollar over the past month, together with the ongoing rise in the cost of electricity and gas, while reimbursements for textile exporters totalling more than Rs700 billion remain unpaid despite numerous assurances. The number of out-of-school children in Pakistan surged past 28 million

Sindh/ Khyber Pakhtunkhwa: Pakistan proposes a significant gas price increase for all consumers

The proposal also suggests mixing 25 per cent locally produced gas and imported liquefied natural gas (LNG) for supply to export-focused industries. As a result, gas prices are expected to become more expensive for provinces such as Sindh and Khyber-Pakhtunkhwa (K-P), both major gas-producing regions, while export sectors will benefit from cheaper gas prices. There are concerns that this approach may lead to litigation between provinces and the federal government, particularly given the existing opposition to subsidised gas supplies to certain areas. Balochistan: Public gatherings banned and highway blockades in the Red Zone

On 15 October, the Balochistan Home and tribal affairs department-imposed restrictions on public gatherings, rallies, and road blockades in the Red Zone of the province under Section 144 of the Criminal Procedure Code. The ban includes gatherings of more than five individuals on national highways, other roads, and within the Red Zone areas. In Quetta, no approvals will be given for public meetings and processions along specific routes. This move is aimed at maintaining law and order and ensuring the free flow of traffic in these areas. Sindh: The Karachi Circular Railway project advances

On 17 October, the interim Chief Minister of Sindh, Justice Maqbool Bagar, discussed the Karachi Circular Railway (KCR) project with Vice President Li Samaa of the China Railway Construction Company (CRCC) during the "Third Belt and Road Forum for International Cooperation" in Beijing. They have agreed to resolve issues related to Right of Way (RoW) and the issuance of a sovereignty guarantee to facilitate the commencement of the long-awaited KCR project. The updated feasibility study for the KCR project has been submitted to the China Railway Authority, and it involves a 43.2-kilometre circular route aimed at reducing traffic congestion and air pollution in Karachi. The project will have 24 stations and is a key infrastructure project under the China-Pakistan Economic Corridor (CPEC).
